THE WEST BENGAL SOCIETIES REGISTRATION ACT 1961**MEMORANDUM OF ASSOCIATION****ALUMNI ASSOCIATION OF GCETT B****PROLOGUE**

Section-1	Whereas the former single faculty "College of Textile Technology, Berhampore" has been changed to multi-faculty "Government College of Engineering and Textile Technology, Berhampore" hereinafter referred to as the College came into effect on and from the first of October 2004.
Section-2	And whereas under new arrangement, as on date, all the authorities and bodies referred to in the Rules, Regulations and Bye-laws of the Dept. of Higher Education, Govt. of West Bengal, continue to exercise all the powers and perform all the duties.
Section-3	And whereas a comprehensive Alumni Association, comprising of all the Alumni of the college could not be formed having well framed and well documented constitution, since the establishment of the college, and so it was felt in a meeting on 25th Dec, 2018 during the Mega Reunion, in presence of Principal, Alumni representatives, Student representatives, Governing Body representatives, Staff Representatives that a fresh Constitution of the Alumni Association of Govt. College of Engineering and Textile Technology, Berhampore' will be framed and the Appropriate association so formed will be registered under appropriate act.
Section-4	And whereas it was considered necessary and expedient to put in place the basic objective for uniting the Alumni of this college for democratic rights, for safe-guarding their interest and to foster the growth of academic and cultural life in this college, for creating a conducive apolitical environment for keeping decorum and sound discipline within the college Campus.
Section-5	And whereas the all-existing Alumni Associations and chapters thereof are expected to declare to abide by all rules and regulations set by this constitution and recast the structure if necessary, giving an undertaking to the new central body that all officers of the existing Associations/ chapters shall serve under the new one.
Section-6	And whereas in pursuance of the directions given by the Government, both at Central and State level, for running and conducting elections etc., the Constitution of the Alumni Association is reframed as hereunder:

INTERPRETATION

Section-1	Unless otherwise explained, the following terms shall have the meaning as shown below:
Section-2	This constitution shall be called the constitution of Alumni Association of GCETT B.
Section-2.1	Registered as Society: Alumni Association of GCETT B (hereinafter referred to as the Association) is an independent society of alumni of "Government College of Engineering and Textile Technology, Berhampore" (hereinafter referred to as Institute/College).
Section-2.2	The Association shall maintain its registered office at the College campus at Berhampore and function from this office and other offices, as may be decided by the authorised body of the Association.

Section-3	"Article" means an article of this Constitution
Section-4	"Authority" means an authority of the college under the govt. or under the Statutes, the Ordinances, the Regulations or the Rules of the government.
Section-6	"Executive Committee" means the executive committee referred to in Article IV.
Section-7	"General Council" means the General Council referred to in Article IV.
Section-8	"Member" of the Union means a regular bonafide student of the college. A casual student shall not be regarded as a member or shall not become eligible for becoming class representative from any section in any branch of study.
Section-9	"Association" means the Govt. College of Engineering and Textile Technology, Berhampore', Alumni Association.
Section-10	"College" means the Govt. College of Engineering and Textile Technology, Berhampore (West Bengal).
Section-11	"Student" means a bonafide undergraduate or post-graduate student
Section-12	defaulter in payment of college tuition fees, who is not penalized for any unfair means at the university examinations.
Section-13	"Term" in this article means consecutive twelve months from the date of this first meeting of elected Alumni Association.
Section-14	In all cases of doubt as to the interpretation of the constitution, the decision of the President of the Association shall be final.
PREAMBLE	
Section-1	We the Alumni of the Govt. College of Engineering and Textile Technology, Berhampore, in order to form a unified Alumni voice to protect apolitically our rights, interests, and opinions, do hereby establish and ordain this Memorandum of Association and Rules & Regulations of the Alumni Association of the college.
ARTICLE I. NAME	
Section-1	The Alumni Association of the alumni of GCETT B shall be known as " Alumni Association of Govt. College of Engineering. & Textile Technology, Berhampore" OR as AAGCETT B OR as "Alumni Association of GCETT B"
ARTICLE II. PURPOSE / MISSIONS / OBJECTIVES	
Section-1	This Association will represent and act on student views and concerns; promote, coordinate, and operate Alumni activities and services; and enhance channels of communication among the alumni, student, faculty, administration, and university community in an orderly and disciplined manner avoiding outside interference and keeping in view the, Govt. rules and regulations
Section-1.1	To provide a vibrant forum that promotes interaction and networking among alumni of the Institute;
Section-1.2	To help alumni achieve their professional and societal goals
Section-1.3	To help alumni in their hour of need

Section-1.4	To create awareness about the Institute/ college and its alumni in the public
Section-2	Promote the development of Alumni skills in leadership, program organization, promotion, communication, initiative and self reliance.
Section-3	Promote the core values of the College of commitment, respect, excellence, accountability and diversity.
Section-4	Support student clubs and organizations activities and programs that benefit the student body academically, socially, intellectually, spiritually, physically and culturally.
Section-5	Support the development of community spirit and student involvement on campus and within the community.
Section-6	The Association shall also render all possible help to the college authority in maintaining decorum and discipline of this college, keeping in view the traditions or heritage of this college.
Section-7	It shall also be directive principle of the activities of the Association to help the student of the college in their preparation for good citizenship and to inspire in them for useful and honest careers in life.

The function and objects of the society shall always remain restricted with the meaning of the section 4(2) of the West Bengal Societies Registration Act 1961 irrespective of any object as mentioned in the present document opposed to the said section. The above objects will be done as per prevailing law of the country.

The income and properties of the society whatsoever derived or obtained shall be applied solely towards promotion of the objects of society and no portion therefore shall be paid to or divided among any of the member




